- 4. Heavy cargo (HEA) is more than 150KG per piece.
- 5. Document Delivery Order (DO) as applicable by the airline.
- 6. Consignments of Human remains (HUM) will be exempted from the above charges.
- 7. Loading /unloading charges are still applicable even if consignee use external workforce.
- 8. For all local services (VAT) will be applicable 5%.
